REVENUE ANTICIPATION NOTE RESOLUTION

At the regular meeting of the Board of Education of the Southern Cayuga Central School District, Cayuga and Tompkins Counties, New York, conducted online via ZOOM, in Cayuga County, New York, on April 22, 2020, at 10:00 AM, Prevailing Time.

The meeting was called to order by Vice President Susan Gloss, and upon roll being called, the following were

The following resolution was offered by Chris Brozon, who moved its adoption, seconded by Matt Bennett, to-wit:

REVENUE ANTICIPATION NOTE RESOLUTION DATED APRIL 22, 2020. A RESOLUTION DELEGATING TO THE VICE PRESIDENT OF THE BOARD OF EDUCATION OF THE SOUTHERN CAYUGA CENTRAL SCHOOL DISTRICT, CAYUGA AND TOMPKINS COUNTIES, NEW YORK, THE POWER TO AUTHORIZE THE ISSUANCE OF AND TO SELL REVENUE ANTICIPATION NOTES OF SAID SCHOOL DISTRICT, IN ANTICIPATION OF THE RECEIPT OF REVENUES FROM CERTAIN SOURCES DURING EACH OF THE FISCAL YEARS OF SAID SCHOOL DISTRICT, COMMENCING JULY 1, 2019, AND JULY 1, 2020.

BE IT RESOLVED by the Board of Education of the Southern Cayuga Central School District, Cayuga and Tompkins Counties, New York, as follows:

Section 1. The power to authorize the issuance of and to sell revenue anticipation notes, including renewals thereof, of the Southern Cayuga Central School District, Cayuga and Tompkins Counties, New York (the "School District"), pursuant to Section 25.00 of the Local Finance Law, in anticipation of the collection of certain revenues due to be received during the fiscal years of said School District, commencing July 1, 2019, and July 1, 2020, being receipt of state aid from the State of New York and aid revenues from the federal government, is hereby delegated to the Vice President of said School District, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be determined by said Vice President pursuant to the Local Finance Law. The determination of the amount of revenue anticipation notes to be issued is hereby delegated to the Vice President of the Board of Education.

Section 2. The Vice President of said School District is hereby authorized to determine the amount of revenue anticipation notes to be issued and to execute such revenue anticipation notes and the closing documentation related thereto in the place of the chief fiscal officer if the chief fiscal officer shall so designate, or in the absence thereof, from the jurisdiction or inability to serve.

Section 3. This resolution shall take effect immediately.
