The Trustees of the Aurora Free Library are seeking a \$6,000 increase. This increase will help support the library's annual operation and maintenance, as well as capital property improvements.

The annual library tax levy would increase from \$110,150 to \$116,150-per year for the support of both the Aurora Free Library and the Hazard Library Association. The school district has a legal obligation to put this proposal before the voters when an increase is requested. It is separate from the school budget proposal.

Shall the following resolution be adopted, to wit:

**RESOLVED** that the Board of Education for the Southern Cayuga Central School District is hereby authorized to raise the tax levy from \$110,150 to \$116,150 for the support and operation of the Aurora Free Library (\$66,150) and the Hazard Library Association (\$50,000). If not approved by the voters, the amount raised will remain at the current annual level of \$110,150.

Shall the following resolution be adopted, to-wit: RESOLVED that the Board of Education of the Southern Cayuga Central School District, Counties of Cayuga and Tompkins, New York, be and hereby is authorized to expend the sum of \$17,790,648 and levy the necessary tax therefore for the 2019/2020 school year.
