RESOLUTION

WHEREAS, Section 913 of the Education Law authorizes the Board of Education to require an employee to submit to a medical examination by a school medical inspector in order to determine the physical or mental capacity of such person to perform his or her duties;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Southern Cayuga Central School District as follows:

<u>Section 1</u>. In accordance with Section 913 of the Education Law, the employee whose examination the Board discussed in executive session on December 12, 2019, is hereby required and directed to submit to an examination by one or more medical inspector(s) designated by the Superintendent of Schools for the purpose of determining the employee's physical and/or mental capacity to perform the employee's duties. The Superintendent shall inform the employee of this resolution.

<u>Section 2</u>. To facilitate this examination, the Superintendent of Schools shall also direct the employee to furnish the medical inspector(s) with releases permitting such inspector(s) to review all relevant medical records from all health care providers with whom the employee has consulted or from whom the employee has received treatment since such date as is deemed appropriate by the medical inspector(s).

<u>Section 3</u>. When the results of such examination are available, the Superintendent of Schools is to share such results with the Board of Education in executive session.

<u>Section 4</u>. This resolution shall take effect immediately.
