Board President Kelsey Rossbach read the following statement to meeting attendees:

"As a general reminder, questions regarding personnel or staff are not appropriate for a BOE meeting and will not be addressed by the Board of Education. For those concerns, please follow the proper procedure:

- Step one is to speak to the individual directly.
- If you continue to have questions or concerns, please speak with their direct manager (Principal, Athletic Director, etc.)
- If you continue to have questions or concerns, speak with the Superintendent.

Regarding the questions from the February 14, 2022 meeting:

• There was a question regarding the process for adding a new sports program. Adding a new sports program should be discussed with the Athletic Director directly, who will then address the concept with the athletic committee. Many determining factors go into the ability for SCCS to host another sports program for SCCS students. All aspects of that would be vetted and discussed in detail before any actions occurred.

- We received a question about our ability to offer 5th and 6th-grade band courses. Since COVID, these grade levels have followed the pod protocol as a safety precaution to reduce any unnecessary spread of COVID-19. As we work to return to a regular schedule and cadence at school, we will also work to provide students with extracurricular courses that enhance their experience at SCCS. This process takes time and is something we are navigating as we go to ensure we continue to follow COVID protocols that are continually changing.
- There have been a few emails and questions regarding the Board of Education's decision to stop the volleyball program. We will start by emphasizing that the SCCS athletics committee and Board of Education have been discussing the viability of continuing with four girls' fall sports teams for many years now. Instead of focusing on eliminating a sport, we would redirect our energy to offer more intramural opportunities for our fifth and sixth grade students as there is a need identified there. In addition, the student population numbers, sports participation/fielding teams, scheduling opportunities for gym space and securing certified coaching staff all pose ongoing challenges. Contemplating the idea of needing to eliminate a sport is a difficult choice, but the strength of future programs requires us to evaluate long term goals. Our volleyball program does not have a feeder program supporting it. Volleyball also takes place in two different seasons. In the fall, when female student athletes reach the JV/Varsity level, choices need to be made between sports they have played at a modified level. The total number of girls in any sport in the fall is then affected by having four offerings. We consistently are unable to field full teams adequately. By reducing fall sports to Cross Country, Swim and Soccer, gym space is freed up in both the fall and winter seasons to develop programming for younger students."
