Almost all of the funds will be devoted to addressing student learning loss from the pandemic. Proposed grant funded positions include an elementary ELL teacher, a bilingual social worker, elementary ELA coaches, elementary math coaches, a curriculum/coach coordinator, local summer school for grades 6 through 11, athletics enrichment for grades 4, 5 and 6, as well as several other possibilities.
