Southern Cayuga Central Schools 315-364-7211 www.southerncayuga.org Southern Cayuga Central School District residents will vote on a \$19,845,920 budget proposal for the 2023-2024 school year on Tuesday, May 16, from 7 am to 9 pm in the District Office. Voters will also select from three candidates for two open seats on the Board of Education, consider additional propositions including a new capital project, the purchase of school buses and an increase of taxpayer support for the Aurora Free Library and the Hazard Library Association.

Southern Cayuga Central Schools proposes a \$15.5 million capital improvement project which will include roof replacement of our high school and bus garage, the replacement of underground heating oil and propane fuel tanks, athletic field improvements, new playground structures, door replacements, water and sewage improvements, new scoreboard, masonry restoration, auditorium seat replacement, and replacement of the bleachers in the high school gym. A comprehensive list of capital project improvements has been identified by our architects and the SCCS BOE Facilities Committee and can be found on our webpage.

The proposed capital project will have a net zero impact on the district budget, as the district will use \$2.4 million from the capital reserve, maximize state building aid, and will retire debt from previous building projects. The project will be eligible for state building aid of 81.2 percent, 4/5ths of the total cost of the project will be covered by the state aid building reimbursement. The remaining local share expense is already included in the general fund budget. The timing for this project is excellent as the projected tax impact is zero. If approved by voters, the design phase would begin immediately and construction would begin in the summer of 2024. Thank you to the residents of Southern Cayuga for your continued support.

The state requires school districts to present their annual budgets in three parts: program, administrative and capital.

**ADMINISTRATIVE**: Salaries and benefits, as well as all other costs to operate the district office and each school's main office and the Board of Education.

**PROGRAM**: Funding for all K-12 educational programs, including teacher and support staff salaries and benefits, BOCES special education and instructional services, interscholastic athletics and transportation.

**CAPITAL**: Includes debt service on buildings, school bus purchases, salaries and benefits of all custodial staff, and all building operation expenses.



**VOTER QUALIFICATIONS** To be eligible to vote on the school budget and election, you must be a citizen of the United States and 18 years of age or older and a legal resident of the Southern Cayuga Central School District for at least 30 days prior to the vote. No prior registration is required. Voter qualifications are mandated in accordance with New York State Education Law. NOTE: Voting inspectors reserve the right to check the driver's license of any voter to verify residency.

#### ABSENTEE BALLOTS

Qualified school district voters may vote in the Annual School District Election and Budget Vote by absentee ballot if they are unable to vote in person on Tuesday, May 16, 2023. To receive an absentee ballot, individuals must first fill out an application for the ballot. Applications are available in the District Office and on our website and may be turned into the District Clerk up to one day before the date of the vote. Absentee ballot applications may be requested from Marcy Hand, District Clerk, by email at handm@southerncayuga.org, by telephone 315-364-7211 or by mail at Southern Cayuga Central School District, 2384 State Route 34B, Aurora, NY. 13026

If the absentee ballot is going to be **mailed** to you, absentee ballot applications must be returned to the District Office at least seven business days before the vote, or at least one day before the vote if you will be picking up the ballot in person at the District Office between 8 am and 4 pm.

When will your absentee ballot be sent to you? If you request on your application that your absentee ballot be mailed to you, the district clerk will mail your ballot by regular mail no later than 6 days prior to the election. Otherwise, the district clerk will deliver your ballot to you or your agent, as designated on your application, when you or your agent appear in the district clerk's office. For your ballot to be canvassed, it must be received by the school district clerk by 5:00 p.m. on the day of the election.







### VOTERS TO DECIDE ON FIVE PROPOSITIONS AND TWO BOARD OF EDUCATION CANDIDATES

#### 1.) PROPOSITION for 2023/24 PROPOSED BUDGET

Shall the following resolution be adopted, to-wit: RESOLVED that the Board of Education of the Southern Cayuga Central School District, Counties of Cayuga and Tompkins, New York, be and hereby is authorized to expend the sum of \$19,845,920; and levy the necessary tax therefore for the 2023/2024 school year?

#### 2.) PROPOSITION for 2023/24 CAPITAL IMPROVEMENT PROJECT

Shall the following resolution be adopted, to-wit: RESOLVED, that the Board of Education of the Southern Cavuga Central School District, Cayuga and Tompkins Counties, New York, is hereby authorized to construct improvements to and reconstruct School District buildings and facilities, including original furnishings, equipment, machinery, apparatus, appurtenances, site improvements, (including athletic field improvements) and other incidental improvements and expenses in connection therewith, at a maximum estimated cost not to exceed \$15,500,000, and that \$2,400,000 of Capital Reserve Fund (2019) monies shall be used to pay a portion thereof, and that the remaining \$13,100,000 of said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District shall be issued.

#### 3.) PROPOSITION for the PURCHASE OF SCHOOL BUSES in 2023/24

Shall the following resolution be adopted, to wit: RESOLVED, that the Board of Education of the Southern Cayuga Central School District, Cayuga and Tompkins Counties, New York, is hereby authorized to pay the cost of (2) 66 Passenger School Buses, (1) 54 Passenger Wheelchair Bus, and (1) Minivan for student transportation including incidental equipment and expenses in connection therewith, at an aggregate maximum estimated cost not to exceed \$551,381 therefor, and that \$551,381, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and in anticipation of such tax, obligations of said School District shall be issued.

#### 4.) PROPOSITION to FUND AURORA FREE LIBRARY

Shall the Southern Cayuga Central School District levy and collect a tax separate and apart from the annual school district budget, pursuant to Section 259 of the Education Law of the State of New York, in the sum of \$80,000 (which is an increase of \$5,000 from the levy in effect from 2022-2023 in the sum of \$75,000) for the continuing support and maintenance of the Aurora Free Library, with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Southern Cayuga Central School District?

#### 5.) PROPOSITION to FUND HAZARD LIBRARY ASSOCIATION

Shall the Southern Cayuga Central School District levy and collect a tax separate and apart from the annual school district budget, pursuant to Section 259 of the Education Law of the State of New York, in the sum of \$56,825 (which is an increase of \$5,000 from the levy in effect from 2022-2023 in the sum of \$51,825) for the continuing support and maintenance of the Hazard Library Association, with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Southern Cayuga Central School District?

<sup>\*</sup> Pursuant to Section 2023 of the Education Law, if the proposed budget is defeated in May, the SCCS Board of Education can put another budget, the same or revised, up for vote in June or immediately adopt a contingent budget. After two unsuccessful votes, the district must adopt a contingent budget. Contingency would mean further reducing the proposed by \$185,105, resulting in additional reductions for programs and services.

## Kishan Zuber


