Southern Cayuga Central School District residents will vote on a \$18,723,991 budget proposal for the 2022-2023 school year on Tuesday, May 17, from 7 am to 9 pm in the District Office. Voters will also select from five candidates for three open seats on the Board of Education and consider two additional propositions, the purchase of school buses and an increase of taxpayer support for the Aurora Free Library and the Hazard Library Association.

The Board of Education proposes a tax levy increase of a half percent (.5%), the second lowest increase in more than 25 years. Last year's tax levy increase was zero percent (0%) and the current proposed budget strikes a balance between student programming, student services, and the lowest tax rate in Central New York. Since 2018, the tax levy per \$1,000 of value has dropped from \$13.53 to \$11.52 in 2021.

District voters will also be asked to approve the continuation of the district bus replacement plan. Each year the district maximizes state aid and the trade-in value of older buses. The process allows the district to maintain a neutral debt load, minimize year-to-year fluctuations in the budget, and to ensure a safe and reliable fleet.

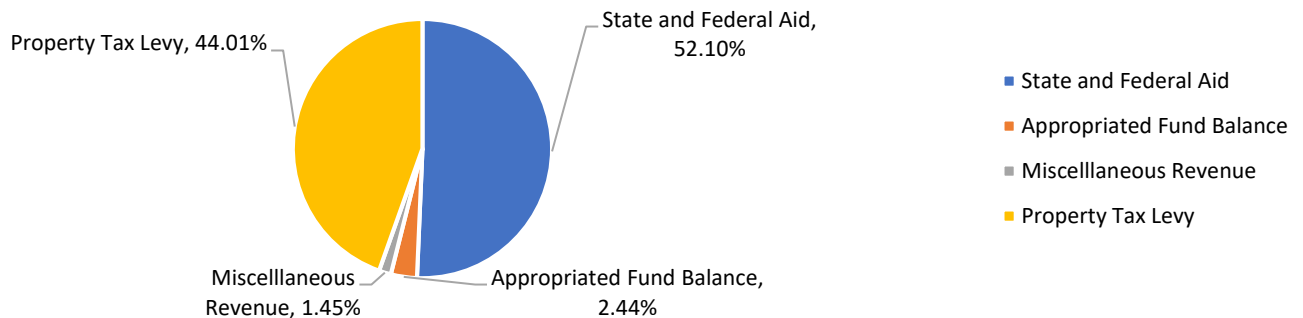

TAX LEVY

What is a “tax levy limit and is SCCS below its limit?

The tax levy limit is the highest allowable tax levy a school district can propose for which only the approval of a simple majority of votes (50 percent plus one) is required. The limit is calculated using a multi-step formula that takes into account any allowable exclusions (such as pension costs and capital expenditures). Any proposed tax levy above this limit requires budget approval by a super majority of voters (60 percent). The 2022/23 budget vote includes a 0.5% percent tax levy increase therefore this year’s levy requires passage by a simple majority of voters.

How is the tax levy different from a tax rate?

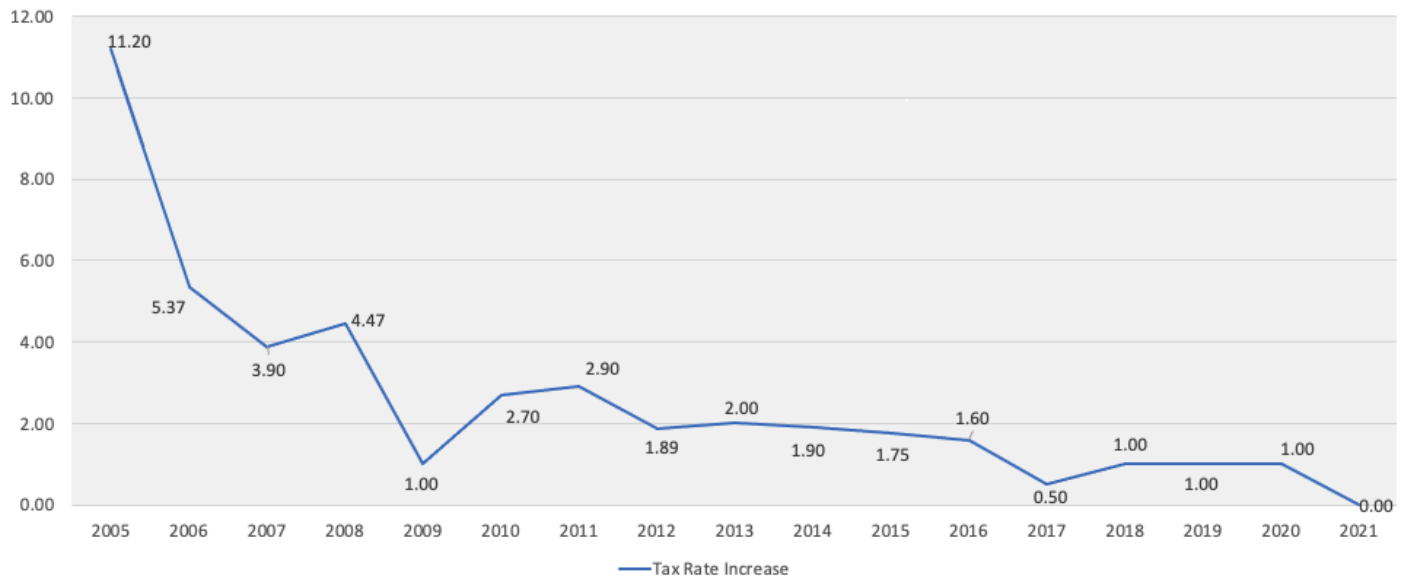
The tax levy is the total amount of money raised from local taxpayers; the tax rate is the amount of tax residents pay per \$1,000 of property value. In 2022/23 the school tax levy will increase by 0.5%.

What happens if the budget is defeated?

If the proposed budget is defeated in May, the SCCS Board of Education can put another budget— revised or not— up for a vote in June or immediately adopt a contingency budget. If the budget is defeated twice, SCCS would have to adopt a contingency budget, with a 0% tax levy increase, which would mean \$185,105 in reductions to programs and services (see page 13).

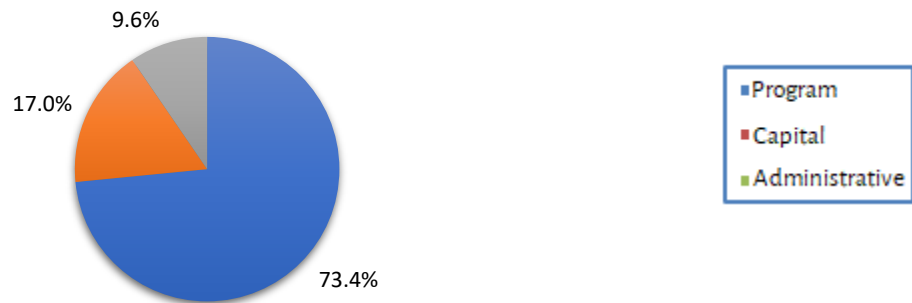

2022-2023: Where Does the Budget Go?

BUDGET NOTICE DEFINITIONS:

The state requires school districts to present their annual budgets in three parts:

- 1) program
- 2) administrative and
- 3) capital.

ADMINISTRATIVE: The administrative portion of the budget provides for the majority of the instructional support services in the district. It includes salaries and benefits of all professional staff members who spend 50 percent or more of their time in administration and supervision; salaries and benefits of clerical staff for administrators; curriculum development and supervision; research, planning and evaluation; central data processing; tax collection; most legal services; and school board costs.

PROGRAM: The program portion of the budget is associated with providing instruction and support services to 700 SCCS students. It includes salaries and benefits of all teachers, guidance counselors, nurses, aides and monitors. It also includes costs for transportation, co-curricular and interscholastic athletics, in-service training, library and health.

CAPITAL: The capital portion of the budget is associated with operating and maintaining the district's 191,400 square feet of buildings and 104.6 acres of grounds. It includes debt service on buildings; school bus purchases; tax certiorari and court-ordered costs; and salaries and benefits of all custodial staff. School districts are required by state law to mail this information to all households within the district. For more budget information, call the District Office at 315-364-7211.



VOTER QUALIFICATIONS

To be eligible to vote on the school budget and election, you must be

- A citizen of the United States
- 18 years of age or older
- A legal resident of the Southern Cayuga Central School District for at least 30 days prior to the vote.

No prior registration is required. Voter qualifications are mandated in accordance with New York State Education Law. **NOTE:** Voting inspectors reserve the right to check the driver's license of any voter to verify residency.

* Pursuant to Section 2023 of the Education Law, if the proposed budget is defeated in May, the SCCS Board of Education can put another budget - the same or revised - up for a vote in June or immediately adopt a contingent budget. After two unsuccessful votes, the district must adopt a contingent budget. Contingency would mean further reducing the proposed budget by **\$185,105**, resulting in additional reductions for programs and services.

INFORMATION REGARDING BALLOT PROPOSITIONS

2022/23 Bus & Vehicle Replacement Plan

The Southern Cayuga School District continues purchasing Matthews buses on a five-year rotation basis. Each bus is purchased with a five-year, 150,000-mile bumper-to-bumper warranty. Our buses travel many miles in our district of 162 square miles. On an annual basis, the District typically has three (3) buses whose warranties will expire. This year voters will be asked to vote on a bus proposition, for approval to replace three (3) buses whose warranties expire at the end of this school year.



Local Libraries

The Trustees of the Aurora Free Library are seeking a \$2,850 increase. This increase will help support the library's annual operation and maintenance, as well as capital property improvements.

The Trustees of the Hazard Library Association are seeking a \$1,825 increase. This increase will help support the library's annual operation and maintenance.

The annual library tax levy would increase from \$122,150 to \$126,825 per year for the support of both the Aurora Free Library and the Hazard Library Association. The school district has a legal obligation to put this proposal before the voters when an increase is requested. It is separate from the school budget proposal.





VOTERS TO DECIDE ON THREE PROPOSITIONS

Proposition # 1 – School Budget

Shall the following resolution be adopted, to-wit:

RESOLVED that the Board of Education of the Southern Cayuga Central School District, Counties of Cayuga and Tompkins, New York, be and hereby is authorized to expend the sum of \$18,723,991.00; and levy the necessary tax therefore for the 2022/2023 school year.

Proposition #2 – Bus Purchases

Shall the following resolution be adopted, to-wit:

RESOLVED, that the Board of Education of the Southern Cayuga Central School District, Cayuga and Tompkins Counties, New York, is hereby authorized to pay the cost of (3) 66 Passenger School Buses at a maximum estimated cost of \$410,000, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District shall be issued.

Proposition #3 – Local Libraries

Shall the following resolution be adopted, to wit:

RESOLVED that the Board of Education for the Southern Cayuga Central School District is hereby authorized to raise the tax levy from \$122,150 to \$126,825 for the support and operation of the Aurora Free Library (\$75,000) and the Hazard Library Association (\$51,825). If not approved by the voters, the amount raised will remain at the current annual level of \$122,150.



BOARD OF EDUCATION

The school board is made up of seven non-paid citizens elected to serve overlapping terms of three years each. Together they establish district policies, develop an annual budget proposal, approve or disapprove the superintendent's recommendations on personnel matters and contracts and act as a communication link between residents and the superintendent.

UNIVERSAL PRE-KINDERGARTEN PROGRAM

New York State Awards Southern Cayuga \$180,000 UPK Grant

The NYS Department of Education approved a \$180,000 UPK grant for 4-year old learners at Southern Cayuga. Beginning in September 2022, Emily Howland will host two Universal Pre-Kindergarten (UPK) classrooms and maintain the current level of programming available for our 36 youngest learners. Last summer, Cayuga County notified the school district they would be ending the Head Start program at Emily Howland. Fortunately, the district had time to apply and successfully attained new funding through New York State. The new UPK classroom will take over the space vacated by the Head Start program.

Southern Cayuga's UPK program will offer comprehensive educational services to residents who will be 4 years of age on or before December 1st and is available at no cost for eligible children. Please contact the elementary office to discuss enrolling your child in our UPK program for the fall of 2022.

PROPOSED CAPITAL OUTLAY PROJECT (\$100K) 2022/2023

Next year's Capital Outlay Project will focus on replacing old classroom doors throughout the UPK-12 Building.

These funds are included in our budget and will be aided at 81.2%.

UNDER CONTINGENCY, THERE WOULD BE \$185,105 WORTH OF REDUCTIONS IN PROGRAMS AND SERVICES

If the proposed budget is defeated in May, the SCCS Board of Education can put another budget – revised or not – up for a vote in June or immediately adopt a contingency budget. If the budget is defeated twice, SCCS would have to adopt a contingency budget, not only would there be a 0% tax levy increase, but it would mean \$185,105 in reductions to programs and services (see page 15).

Adopting a contingency budget would prohibit SCCS from spending any money in certain areas, including community use of school facilities (unless all costs are reimbursed to the district); new equipment purchases; non-essential maintenance; capital expenditures (except in emergencies); salary increases for non-instructional, non-unionized employees; and certain field trips and student supplies. Contingency rules also cap the growth of the administrative component of the budget. Therefore, if we are forced to a contingency budget, it becomes mandatory to cut these items out of the budget.



ABSENTEE BALLOTS

Qualified school district voters may vote in the Annual School District Election and Budget Vote by absentee ballot if they are unable to vote in person on Tuesday, May 17, 2022. Individuals who may use an absentee ballot include those who are temporary or permanently ill (temporary illness includes being unable to appear due to risk of contracting or spreading a communicable disease like COVID-19), hospitalized, physically disabled, away on business, on vacation or who are detained in jail awaiting action by grand jury, awaiting trial or confined for an offense other than a felony.

To receive an absentee ballot, individuals must first fill out an application for the ballot.

Applications are available in the District Office and on our website and may be turned into the District Clerk up to one day before the date of the vote. Absentee ballot applications may be requested from Marcy Hand, District Clerk, by email at handm@southerncayuga.org, by telephone 315-364-7211 or by mail at Southern Cayuga Central School District, 2384 State Route 34B, Aurora, NY. 13026

Absentee ballot applications must be returned to the District Office at least seven business days before the vote, if the ballot is going to be mailed to you. Or at least one day before the vote if you will be picking up the ballot in person at the District Office between 8 am and 4 pm.

When will your absentee ballot be sent to you? If you request on your application that your absentee ballot be mailed to you, the district clerk will mail your ballot by regular mail no later than 6 days prior to the election. Otherwise, the district clerk will deliver your ballot to you or your agent, as designated on your application, when you or your agent appear in the district clerk's office. For your ballot to be canvassed, it must be received by the school district clerk by 5:00 p.m. on the day of the election.

Remember—Absentee ballots must be returned no later than 5:00 pm on Tuesday, May 17, 2022.

This school year, enrollment in our Agricultural classes has increased by more than 50%.



Our greenhouse has been updated to offer year 'round growing opportunities for our students.
Our Agricultural program is one of 30 school programs, nationally, that will be offering CASE AgX curriculum for our Jr. High students in 2022-2023.
Ms. Wasson is a CASE certified and lead teacher. The CASE model is a national rigorous and relevant curriculum developed to guide students in their studies to meet the demands of post-secondary education and careers in the Agriculture, Food, and Natural Resources (AFNR) industries.
Plant Science students have learned how to install drip irrigation, ground covering and other advancements to create a functional commercial greenhouse setting. 2021 Cornell Agriculture Incentive grant funds were used to purchase new hydroponic grow towers.
